

RESOLUTION NO. R-77-1079

RESOLUTION TO CHANGE THE STREET NAME OF CUBBY TRAIL IN PHEASANT WALK, SECTION I, RECORDED IN PLAT BOOK 31, PAGE 323 IN SECTION 36, TOWNSHIP 46 SOUTH, RANGE 42 EAST TO COVEY TRAIL.

WHEREAS, Section 33S.05, Florida Statutes, authorize the Board of County Commissioners to name and rename streets and roads lying outside the limits of any incorporated municipality; and,

WHEREAS, the property owners abutting Cubby Trail is desirous of renaming the street to Covey Trail as evidenced by the petition attached hereto and made a part hereof, and,

WHEREAS, the street sign in Pheasant Walk reflects the aforementioned road as Covey Trail; and which the abutting homeowners are presently using for mailing purposes; and,

WHEREAS, the Developer wishes to carry on the rustic theme of Pheasant Walk in their street naming process; and,

WHEREAS, the Palm Beach County Planning, Zoning and building Department has reviewed the attached petition for compliance with Section 336.05, Florida Statutes, and has no objection thereto,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. the foregoing recitals are hereby affirmed and ratified;
2. that certain street known as Cubby Trail in Section 36, Township 46 South, Range 42 East in the unincorporated area. of Palm Beach County is hereby declared to be known as Covey Trail;
3. certified copies of this resolution shall be forwarded to the Office of the Clerk of the Circuit Court for proper notation on the plat or other appropriate, map and to the Main Branch of the United States Post Office in West Palm Beach, Florida; and,
4. the Planning, Zoning and Building Department is hereby instructed to notify the Palm Beach County Sheriff's Department, the Fire District and Ambulance Service which serves the area, the Land Acquisition and Land Development Divisions of the Engineering Department of the name change.

The foregoing resolution was offered by Commissioner

Medlen , who moved it's adoption. The motion was seconded by Commissioner Evatt , and after being put to a vote, the vote was as follows:
